**Hiring of a Consultancy Group for the Production and Airing of Season 6  
(Year 6) "RADYO MO SA NUTRISYON" Nutrition Blocktime Radio Program**

1. The NATIONAL NUTRITION COUNCIL, through the General Fund intends to apply the sum of Six Million Three Hundred Thousand Pesos (P6,300,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Hiring of a Consultancy Group for the Production and Airing of Season 6 (Year 6) "Radyo Mo Sa Nutrisyon" Nutrition Blocktime Radio Program. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The National Nutrition Council now calls for the submission of eligibility documents for Hiring of a Consultancy Group for the Production and Airing of Season 6 (Year 6) "Radyo Mo Sa Nutrisyon" Nutrition Blocktime Radio Program. Interested consultants must submit their Letter of Intent on or before **02 March 2015 at 5:00 p.m.** Submission and opening of eligibility documents is on or before **05 March 2015 at 2:00 p.m.** Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. The BAC shall draw up the short list of consultants from those who have submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:
  1. Applicable Experience (40%)
  2. Current Workload (25%)
  3. Qualification of Personnel (35%)

**Pre-bidding Conference will be held on 06 March 2015 at 2:00 p.m.**

**Opening of Bids will be held on 23 March 2015 at 2:00 p.m.**

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

4. The National Nutrition Council shall evaluate bids using the *Quality Cost Based Evaluation (QCBE)*. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposal. The criteria and rating system for the evaluation of bids will be as follows:
  - A. Technical Proposal – Weighted Score (75%)
    1. Quality, experience and capability of the consulting firm/contractor (30%)
      - a. Conduct of similar projects in the last 3 years (15%)
      - b. Quality/scope of implementation (15%)

2. Quality and experience of project team to deliver requirements indicated in the TOR (30%)
3. Quality of the overall plan, strategy/approach and methodology to be used (40%)

B. Financial Proposal – 100% Weighted Score (25%)  
Minimum Total Score Required (TP & FP) is 75%

5. The contract shall be completed within one (1) year.
6. The National Nutrition Council reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
